Dear Parent or Guardian:

We are pleased to announce that in accordance with NCA 07-068, the Mvskoke Language Program is hosting its 18th annual Language Immersion Camp. Students must be entering 7th grade through 12th grade. (Student cannot be 18 prior to June 9th, 2025). Students must be enrolled Muscogee (Creek) citizens & have the desire to learn of the Mvskoke Language in all aspects. Must submit a 200-word essay, typed in Microsoft Word pertaining to the Importance of Preserving the language. The 5-day camp will be held at the Sequoyah State Park, Hulbert, OK.

*Must submit to a head lice check the morning of the first day of camp-prior to departing for camp. The check will be conducted by the Nation's Health official. Any student found with head lice will not be allowed to attend. Parent must remain until the child (ren) have been cleared from this check.

These are the following guidelines that we need for you to discuss with your child (ren).

BEHAVIOR:

- Must obey all rules set by the staff.
- Be respectful to everyone and everyone's property.
- Students must stay within the Sequoyah State Park | Hulbert, OK boundaries at all times.
- Attend all classes and activities. Be on time.
- Do not be late for meals. Meals will be served during scheduled time only.
- Girls are not allowed in the boy's room and the boys are not allowed in the girl's rooms.
- Students need to be in their rooms by 10:00 p.m. **LIGHTS OUT AT 10:30 p.m.**
- Students must comply with the cell phone rule. (No cell phones or electronic games during class or activity time.)
- Alcohol, Cigarettes/ Vapor or Tobacco products will not be tolerated

SAFETY:

• Report any illness or injury to a staff member immediately.

PERFORMANCE:

- Have a positive attitude and display good sportsmanship.
- Participate and put your best efforts into all activities.
- Speak and attempt to learn the Mvskoke Language as much as possible.

REQUIRED ATTIRE:

- Name tags must be worn at all times.
- Correctly fitting clothing: t-shirts, no spaghetti straps, shorts (one inch above knee only), capris, sneakers, light jacket.
- No sagging jeans or shorts, no expensive personal items.

SWIMMING ATTIRE:

- Girls-One piece suit. No two-piece swim suit.
- Boys-Swimming trunks that fit.

The Charter bus will leave no later than 10:30 AM, Monday June 9th

Students will need to be here no later than 10:00 am and may arrive as early as 9:00 am on Monday, June 9th 2025. *Students will be ready for pick up on Friday, July 13th, 2025 at approximately 12:00 pm.
